**Equipment Rental Rate: \$10.00 per acre. (\$75 minimum charge) \$100.00 Security Deposit required with an additional charge for each day that the rental property is held over plantable days. (Calculated on a 25 acre per day planting rate ). \$100.00 Cleaning Charge assessed if Seed box and Seed Tubes are not cleaned out before returning. \$100 Out-of-County charge for use outside of Clark County, IN (in addition to per acre rate).**

**I. Use of the Rental Property:** The Lessee at his/her own costs and expense, will use the Rental Property in a careful and prudent manner, keeping the same in good repair at all times by an experienced and competent operator.

**II. Rental Property** shall be picked-up at the Clark County SWCD office by the Lessee immediately prior to use. Said property shall be returned to the SWCD office immediately following use unless prior approval is obtained from the SWCD staff. Untimely return of the Rental Property shall result in additional charges as stated above.

**III. Assumption of Risks:** It is understood and agreed that the Lessee is an independent contractor and is not the agent, servant or employee of the Lessor in any manner whatsoever, and the Lessee assumes all risks resulting from the use of the Rental Property, and agrees to save harmless the Lessor from any and all liability for injury to persons or damage to property caused by the Rental Equipment or the use thereof.

**IV. Damages:** The lessee will be responsible for repairs if damages occur while in his/her possession.

**V. Scheduling:** Scheduling of drill will be done by the SWCD on a weekly basis. Scheduling is subject to revision due to equipment failure.
